

The Franklin County Board of Education met in regular session at the Franklin County Schools' Riverside Campus. The following members were present: Chair Paige Sayles, Vice Chair Bernard Hall, Mrs. Debra Brodie, Mrs. Rosemary Champion, Mrs. Meghan Jordan, and Dr. Elizabeth Keith. Superintendent Dr. Rhonda Schuhler and Attorney Boyd Sturges were present. Chair Paige Sayles called the meeting to order.

A Moment of Silence was observed, and the Pledge of Allegiance was recited.

A motion was made by Dr. Elizabeth Keith, seconded by Mrs. Debra Brodie, and unanimously carried to approve the agenda.

During Public Comments, Mr. Derrick McRae, parent of students in Fraklinton High School and Cedar Creek Middle School, thanked the board for its work and praised Franklin County Schools.

A motion was made by Mrs. Rosemary Champion, seconded by Vice Chair Bernard Hall, and unanimously carried to approve the consent agenda that consisted of the June 10, 2019 and June 27, 2019 board minutes.

A motion was made by Vice Chair Bernard Hall, seconded by Dr. Elizabeth Keith, and unanimously carried to approve Policies 7100 Recruitment and Selection of Personnel, 7300 Staff Responsibilities, 9110 Selection and Use of Architects, Engineers, Surveyors, and Construction Managers at Risk, and 9120 Bidding for Construction Work as presented.

Dr. Lela Baldwin, Chief of Academics, presented revisions to Policies 3101 Dual Enrollment, 4240 Child Abuse Reports and Investigations, and 4700 Student Records. No action was taken; these policies will be posted for review for one month, to be voted on in August.

Superintendent Dr. Rhonda Schuhler gave a brief oral Superintendent's Report.
